(ALSO APPLIES TO BOARD COMMITTEES)

#### **PUBLIC INPUT**

A member of the public may address the Board on agenda items, before or during the Board or Committee's consideration of the item for one (1) minute per item, or at the discretion of the Chair. A request to address the Board must be submitted electronically using the tablets available in the Board Room lobby. Individuals requesting to speak will be allowed to speak for a total of three (3) minutes per meeting on agenda items in one minute increments per item. For individuals requiring translation service, time allowed will be doubled. The Board shall reserve the right to limit redundant or repetitive comment.

The public may also address the Board on non-agenda items within the subject matter jurisdiction of the Board during the public comment period, which will be held at the beginning and/or end of each meeting. Each person will be allowed to speak for one (1) minute during this Public Comment period or at the discretion of the Chair. Speakers will be called according to the order in which their requests are submitted. Elected officials, not their staff or deputies, may be called out of order and prior to the Board's consideration of the relevant item.

Notwithstanding the foregoing, and in accordance with the Brown Act, this agenda does not provide an opportunity for members of the public to address the Board on any Consent Calendar agenda item that has already been considered by a Committee, composed exclusively of members of the Board, at a public meeting wherein all interested members of the public were afforded the opportunity to address the Committee on the item, before or during the Committee's consideration of the item, and which has not been substantially changed since the Committee heard the item.

In accordance with State Law (Brown Act), all matters to be acted on by the MTA Board must be posted at least 72 hours prior to the Board meeting. In case of emergency, or when a subject matter arises subsequent to the posting of the agenda, upon making certain findings, the Board may act on an item that is not on the posted agenda.

**CONDUCT IN THE BOARD ROOM** - The following rules pertain to conduct at Metropolitan Transportation Authority meetings:

**REMOVAL FROM THE BOARD ROOM** - The Chair shall order removed from the Board Room any person who commits the following acts with respect to any meeting of the MTA Board:

- a. Disorderly behavior toward the Board or any member of the staff thereof, tending to interrupt the due and orderly course of said meeting.
- b. A breach of the peace, boisterous conduct or violent disturbance, tending to interrupt the due and orderly course of said meeting.
- c. Disobedience of any lawful order of the Chair, which shall include an order to be seated or to refrain from addressing the Board; and
- d. Any other unlawful interference with the due and orderly course of said meeting.

#### **DISCLOSURE OF CONTRIBUTIONS**

The State Political Reform Act (Government Code Section 84308) requires that a party to a proceeding before an agency involving a license, permit, or other entitlement for use, including all contracts (other than competitively bid, labor, or personal employment contracts), shall disclose on the record of the proceeding any contributions in an amount of more than \$250 made within the preceding 12 months by the party, or his or her agent, to any officer of the agency, additionally PUC Code Sec. 130051.20 requires that no member accept a contribution of over ten dollars (\$10) in value or amount from a construction company, engineering firm, consultant, legal firm, or any company, vendor, or business entity that has contracted with the authority in the preceding four years. Persons required to make this disclosure shall do so by filling out a "Disclosure of Contribution" form which is available at the LACMTA Board and Committee Meetings. Failure to comply with this requirement may result in the assessment of civil or criminal penalties.

- A. Schedule of Revenues and Expenditures for Measure M Special Revenue Fund for the Fiscal Year ended June 30, 2022, completed by BCA Watson Rice, LLP (BCA);
- B. Compliance with Requirements Applicable to Measure M Ordinance and Measure M Local Return Guidelines for the Fiscal Year ended June 30, 2022, completed by Vasquez & Company, LLP (Vasquez); and

With regards to the audit completed by BCA Watson, Director Stanger questioned what the "other" costs were that appear to escalate quickly. Staff responded that they account for salary wages and fringe benefits associated with Measure M projects. Director Stanger also questioned why the audits did not confirm the required allocations of Measure M funds to its nine Subfunds. He noted apparent discrepancies between the annual audit and the annual budget figures and said it was difficult to compare the two.

Related to the Vasquez & Company, LLP audit and the discrepancies that have been noted year over year, Metro staff explained that lack of personnel at the cities has created an issue for reporting.

After some discussions regarding the audit completed by Simpson and Simpson, CPA, and the notification process, Director Briskman asked staff to make sure their contact list of City Managers is updated annually.

After the presentation, it was determined that a reconciliation sheet would be helpful to paint a full picture of the budget.

Staff responded that construction of the LA River Bike Path project and many others would not be funded with Active Transportation funds but with other funds. Director Stanger asked that staff prepare a list of just what projects the Active Transportation funds will be funding with its 2% allocation.

Director Rajmaira asked why the projects are in 2015 dollars and how it compares to today's dollars. Staff responded that 2015 is used as a basis until projects receive an updated forecast. The projects are tracked against the Measure M Ordinance and once the 5-year assessment is completed, it will include updated forecasts.

Chair Tanzmann mentioned that the Active Transportation Strategic Plan caught her attention and requested a presentation at the next meeting.

- Structures (Inspections) Contract FY23, in contract year 4 of 5. Completed 49 of 68 inspections, 19 in progress as of mid-May 2023. Coordinating with Ops and Program Management to resolve defects found by consultant.
- Awarded Facilities Condition Assessment 3-year contract in May 2022 for FY23-25 required assessments. 60 of 63 inspections performed in FY23 to date, with 3 inprogress. Reports being finalized.
- Train Control Assessment Study went out for bid/proposals as of March 2023, scheduled for award in July, pending issues during the procurement process.

- August Validate information with asset owners.
- September Formulate Performance Measures and Targets information, Written Narrative, begin preparing multiple (16) asset reports by ETAM, including Group TAM Plan targets for upload into the National Transit Database (NTD) by deadline.
- October Receive Executive Approval to upload Metro Performance Target data into NTD and execute upload.


